Warranty Coverage

Klauer Manufacturing Company ("Klauer Manufacturing") steel products painted with the Steel Siding, Rainware and Flashing Color Collections, subject to the limitations and conditions set forth below, are warranted by Klauer Manufacturing, 1185 Roosevelt Ext., Dubuque, IA 52001, to registered Owner(s) of the property on which the warranted products are installed whose property is located within the Continental United States and Canada, that if due to manufacturing defects Steel Siding and Accessories, Steel Rainware and Accessories and Steel Flashing (hereinafter referred to as the "Product") applied to the premises owned by the Owner cracks, chips, blisters, flakes or peels during normal weathering, Klauer Manufacturing will, upon notification and verification of the defects, either repair, replace or refund the defective Product in accordance with the terms and conditions of this Warranty for as long as the original property Owner(s) are living and are the Owner(s) of the property to which the Product was applied. In the event there is more than one original property Owner(s), the Warranty will remain in effect as long as one of the original property Owner(s) is living and owns an interest in the property to which the Product was applied.

Because this Warranty was created to cover the Product of individual property Owner(s) for the property Owner's lifetime (human beings), this Warranty, except as set forth below, does not cover Product applied to property owned in whole or in part by corporations, governmental entities or agencies, religious organizations, trusts, condominium or corporate housing arrangements, intangible legal entities or any other entity or organization capable of an infinite life. For such intangible entities capable of an infinite life, the duration of the Warranty provided hereunder is fifty (50) years from the date of installation of the Product.

The period of the Steel Siding Color Collection Hail Protection Warranty for individual owners and intangible entity owners is fifty (50) years beginning on the application date of the Product to your property was completed. This Hail Protection Warranty is available only in the Continental United States and Canada and applies to Steel Siding only. If the Product is severely damaged by hail during the Warranty period, and to the extent that such damage is not otherwise covered by insurance coverage, such as homeowners insurance, Klauer Manufacturing will, upon notification and validation of the claim, subject to the proration provisions set forth below, either repair, replace or refund only those Products severely damaged by hail. Klauer Manufacturing adheres to established insurance industry standards and practices for the evaluation of physical hail damage. Mere cosmetic damage including, but not limited to dents, that do not affect the performance of the product are not covered under this Warranty.

Owner must first file a claim with their property insurance (such as homeowners insurance) to cover the damage. To the extent that such damage is covered by the Owner's insurance policy, Klauer Manufacturing shall be responsible for paying the pro-rata portion of the deductible applicable to the Products. To and only to the extent the Owner's insurance policy does not cover the damaged Products, then the Limited Hail Protection Warranty will go into effect subject to the terms and conditions of this Warranty. Klauer Manufacturing will assume only the cost of material to repair or replace the damaged Product upon payment by the Owner of \$300 for each incident under this Hail Protection Warranty. Upon payment of \$300, Klauer Manufacturing will be responsible for 100% of repair costs in the first five (5) years from the date of original installation, 70% of repair costs for years 6–10, 50% of repair costs for years 11–15, 30% of repair costs for years 16–20, 20% of repair costs for years 21–30 and 10% of repair costs thereafter. For purposes of the Hail Protection Warranty, costs are defined as material only.

Klauer Manufacturing further warrants that the Product, after removal of foreign surface deposits, will not fade or change color

in excess of five (5) Delta E Units for vertical surfaces and seven (7) Delta E Units for non-vertical surfaces for a period of thirty-five (35) years from the date of original installation as measured using the procedure of ASTM D-2244, comparing an unexposed panel to the exposed panel after removal of dirt and chalk.

Additionally, Klauer Manufacturing warrants that the Product will not chalk in excess of ASTM D-4214 rating of eight (8) for vertical surfaces and six (6) for non-vertical surfaces for a period of thirty-five (35) years from the date of original installation. All warranties are subject to the conditions, remedies, limitations and legal rights stated in this certificate.

Limitations and Exceptions

Klauer Manufacturing does not warrant against and shall not be liable for any damage to the Product when due to any of the following causes: faulty or improper installation or application of the Product; use of accessories other than genuine Klauer Manufacturing accessories; settlement, shrinkage, distortion, warping, failure or cracking of the wall or materials to which the Product is applied; earthquake, hail (except to the extent provided in the separate hail damage Limited Warranty), hurricane, tornado, cyclone, gale, lightning, fire, Acts of God, flood, wind-borne objects, ice or weather of a catastrophic nature as defined by the United States Weather Bureau; exposure to corrosive atmospheres such as those contaminated with salt or salt spray, acid rain, harmful chemicals or vapors; surface discoloration due to air pollution, direct contact with chemically incompatible conditions, normal weathering of surface, fumes or vapors directly applied to the siding or in the atmosphere; lap abrasion, vandalism, misuse, physical abuse, riot insurrection or civil disorder or negligence in or failure to provide reasonable and necessary maintenance of the Product to prevent an accumulation of surface dirt, staining or mildew. (Please see care and maintenance instructions.)

"Normal weathering" is defined as the damaging effects of sunlight and extremes of weather and atmosphere that may cause any colored surface to chalk, fade or become soiled or stained. The degree to which normal weathering occurs depends on air quality, the building's location and other local conditions of which Klauer Manufacturing has no control.

Due to normal weathering, Products repaired, replaced or refinished during the Warranty period may differ in gloss and color from Products that were originally installed, if any of such Products remain on the property. Klauer Manufacturing in repairing, replacing or refinishing a defective or damaged Product will attempt to match the existing siding within the limits of its existing normal Product line, but will not be responsible (except to the extent provided in the separate Limited Warranty against excessive fading) to repair, replace or refinish Product which is not defective in order to match the gloss and color of the remaining Product.

Minor film cracking and other anomalies occurring during embossing or forming processes are classified as standard manufacturing characteristics and do not constitute a functional material defect or a covered loss under warranty. To qualify as a warrantable deficiency, film anomalies, including cracking, chipping, blistering, or peeling, must be identifiable via a visual inspection from a minimum distance of three feet, under normal lighting conditions, and without the use of magnification. Defects not visible at this threshold are categorized as sub-threshold and do not meet the criteria for a material failure claim.

The Product is not intended for use within one (1) mile of any body of saltwater and this Warranty will not apply to any products installed within one (1) mile of any body of saltwater.

This Warranty is not applicable to motor, modular, mobile or other transportable structures.

Warranty continued

Mandatory Registration

The obligations of Klauer Manufacturing under this Limited Warranty shall become effective only if the original Property Owner(s) fully and accurately complete, sign and mail this registration, by certified mail, to Warranty Registration Dept., Klauer Manufacturing Company, 1185 Roosevelt Ext., Dubuque, IA 52001, or through the Online Warranty Registration link at www.klauer.com, within thirty (30) days of the completed installation. If the Warranty is not registered in a timely manner Klauer Manufacturing shall have no obligation under this Limited Warranty.

Claim Notification

The Owner must present their claim in writing within ninety (90) days of discovering the claimed defect, by certified mail, to Warranty Claims Dept., Klauer Manufacturing Company, 1185 Roosevelt Ext., Dubuque, IA 52001, if the Owner feels the product is defective or has any other claim under warranty. The written notification must show the Owner(s) name, address, a brief description of the Product and the defect thereof, the name of the contractor and the date of installation.

Do not begin any repairs prior to writing Klauer Manufacturing and receiving written permission to do so. Some methods of remedy may ruin the Product, making it impossible for Klauer Manufacturing to repair. Further, Klauer Manufacturing must have a reasonable opportunity to inspect the Product for defects before repairs are approved.

Upon receipt of claim notification Klauer Manufacturing shall have the right to inspect the Product on the Owner's premises to verify that the Product has failed under the terms of this Warranty. Such inspection will be undertaken as soon as practicable after receipt of notice. After its inspection, Klauer Manufacturing will notify the Owner whether the claim has been accepted, and if so, the manner in which it intends to remedy the defect.

Conditions

Klauer Manufacturing reserves the right to discontinue or make changes to its Product. If your Product is not available and Klauer Manufacturing decides to replace the defective Product, Klauer Manufacturing shall have the right to substitute Product which it considers of equal quality or price. All warranty claims shall be settled between you and Klauer Manufacturing, but Klauer Manufacturing may direct and pay a company, dealer, contractor, applicator or distributor to perform any remedy under this Warranty on Klauer Manufacturing's behalf.

Remedies

If the Product shows manufacturing defects within the first three (3) years from the date of installation, Klauer Manufacturing, at its option, will either repair, refinish, replace or refund the defective Product at no cost as defined below to the original Owner. In such event, Klauer Manufacturing shall assume the cost of materials only.

(a) \$100 payment

After the first three (3) years from the date of installation, Klauer Manufacturing will assume the cost of material and labor for any authorized warranted work upon Klauer Manufacturing's receipt of a \$100 payment* from the property Owner for each incident under this warranty.

(b) Hail Protection – \$300 payment

In the event of hail damage in the Continental United States and Canada, Klauer Manufacturing will assume only the cost of material to repair, replace, refinish or refund the damaged siding panels for any authorized warranted work upon Klauer Manufacturing's receipt of a \$300 payment** from the property Owner for each incident under this warranty. If refund is to be made, the \$300 will be deducted from the refund amount. For purposes of the Hail Protection Warranty, costs are defined as cost of materials only and exclude cost of labor.

(c) Limitation of Klauer Manufacturing's liability for each claim

Klauer Manufacturing's total liability for a claim under this warranty shall be limited to, and in no event exceed, the original total purchase price, excluding labor and taxes, of the installed Product. Any costs and expenses beyond Klauer Manufacturing's liability under the terms of this Warranty shall be paid to Klauer Manufacturing or otherwise paid by the Owner(s) prior to Klauer Manufacturing's commencing warranty work on any claim which exceeds Klauer Manufacturing's total liability.

If Klauer Manufacturing is unable to provide replacement, and repair or refinishing is not commercially practical or cannot be made within a reasonable time period, Klauer Manufacturing shall have the right to elect to refund to the Owner the remaining portion of the initial installed cost of the product found to be defective, in accordance with the terms and conditions as stated in this certificate.

If the Owner is not satisfied with the response to the claim, or there is a problem with the warranty service or performance, the Owner may pursue specific legal remedies. This warranty gives the Owner specific legal rights; the Owner may also have other rights which vary from state to state.

Exclusions and Limitations

Klauer Manufacturing is giving you an express lifetime limited warranty under the provisions of the Magnuson-Moss Federal Warranty Act. KLAUER MANUFACTURING SHALL NOT BE RESPONSIBLE TO THE OWNER FOR CONSEQUENTIAL DAMAGES OR INCIDENTAL DAMAGES RESULTING FROM BREACH OF ANY EXPRESS, WRITTEN, ORAL OR IMPLIED WARRANTY OF THE PRODUCT. Some states/provinces do not allow this exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to the Owner. THERE IS NO WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, AND ALL IMPLIED WARRANTIES OR OTHER WARRANTIES NOT SET FORTH EXPRESSLY HEREIN ARE DISCLAIMED TO THE FULL EXTENT DISCLAIMER IS PERMITTED BY LAW. IN ANY EVENT, ANY IMPLIED WARRANTY THAT MAY ARISE BY LAW AND IS NOT DISCLAIMABLE IS LIMITED IN DURATION TO THE TERM HEREIN. Some states do not allow limitations on how long an implied warranty lasts, so the above limitations may not apply to the Owner.

Your exclusive remedy shall be replacement, repair, refinishing or refund solely at Klauer Manufacturing's option, only on the terms stated in this certificate.

This writing contains the entire agreement between Klauer Manufacturing, manufacturer of the product, and the Owner, and the Warranty expressed herein excludes and is in lieu of all other express warranties, whether made by a franchisee, salesperson, employee, dealer, contractor, applicator, distributor, agent or other persons or entities.

For Products Sold in Canada

For products sold or installed in Canada, this Warranty is provided subject to applicable federal, provincial, and territorial laws, and nothing in this Warranty is intended to exclude, restrict, or modify any rights or remedies that cannot be lawfully excluded, restricted, or modified. Any disclaimer of implied warranties or conditions, including merchantability or fitness for a particular purpose, and any limitation of remedies, shall apply only to the extent permitted by applicable law. The remedies described in this Warranty (including repair, replacement, refinishing, or refund) are intended to define the Company's obligations under this express limited warranty and shall not exclude any non-waivable statutory rights or remedies.

Registration, notice, and claims procedures apply to the administration of this Warranty only and do not limit any rights available for non-waivable warranties under applicable law. For products sold to consumers in the Province of Quebec, the consumer

may benefit from the legal warranty provided under the Consumer Protection Act, which provides that goods must be fit for ordinary use, durable for a reasonable period, free from hidden defects, and consistent with their description and representations, and this Warranty does not limit or replace such rights. References in this Warranty to rights varying from "state to state" shall be deemed to refer to rights varying from "province/territory to province/territory," respectively, and any reference to U.S. law, including the Magnuson-Moss Warranty Act, shall not apply to products sold in Canada. Nothing in this Warranty, including any entire-agreement provision, is intended to exclude or limit any representations or rights that give rise to remedies under applicable law.

Transfer of Warranty

This Warranty is transferable once by the original property Owner(s) to the immediately subsequent owner of the property to which the Product was applied, upon payment of a \$300 transfer fee, provided that, the original property Owner (or subsequent registered transferee) sends, by certified mail, to Warranty Transfer Dept., Klauer Manufacturing Company, 1185 Roosevelt Ext., Dubuque, IA 52001, a certification of the transfer signed by the original property Owner (or subsequent registered transferee) and the \$300 transfer fee within thirty (30) days following transfer of the title to the new property owner. Upon transfer, all warranty periods, except chalk and color change, shall be prorated and limited in duration to fifty (50) years from the date of the installation of the Product as indicated in the warranty transfer schedule. Chalk and color change warranties shall be prorated as shown on the warranty transfer schedule, but limited to the time of thirty-five (35) years as indicated under Warranty Coverage. This section does not apply to entities capable of infinite life.

Warranty Obligations Upon Transfer of Warranty*

Upon proper transfer, this Warranty shall be limited to fifty (50) years from the date of original installation. During this period, Klauer Manufacturing will be responsible for 100% of costs*** for the first five (5) years from the date of original installation, 75% of costs in years 6–10 and 50% of costs for years 11–50.

Should remedy for manufacturing defects be necessary under the terms of this prorated transferable Warranty, Klauer Manufacturing reserves the right to require Owners to pay their prorated portion of refinishing, repair or replacement costs in advance.

* Subject to payment of \$100 service charge per incident for claims made from the 4th year through end of applicable warranty period.

** Subject to payment of \$300 service charge per incident for claims made during applicable warranty period.

*** Costs, for the purposes of basic warranty coverage, are defined as only the material costs to repair and replace defective siding. Under hail warranty coverage, costs are defined as the cost of material only and exclude cost of labor.

Care and Maintenance Instructions

As a major provider of exterior building products, Klauwer Manufacturing is proud to say that all its products are manufactured in the U.S.A.

Imaginative design, innovative manufacturing processes and extensive quality control produce clearly superior product finishes on our Steel Siding, Steel Rainware and Accessories and Steel Flashing that are some of the most durable and beautiful available. They require only minimal maintenance. Our design specialists work with color consultants and engineers to ensure our building products are as visually appealing as they are well made. From the drawing board to the loading dock, quality control is given top priority. How to Clean

The Product's finish is recognized as a reliable and durable coating, but as with any exterior surface, dirt and mildew may collect on it. Where conditions of soiling do occur, the following instructions will enable you to care for the finish on your Product.

For surface dirt, an occasional washdown with a garden hose and a soft bristle brush is recommended. In moderately dirty atmospheres, wash in the same manner, but replace clear water with a normal solution of water and normal household detergent.

In heavy industrial atmospheres, use ordinary nonabrasive household detergents, such as 1/3 cup detergent (Tide®, for example) and 2/3 cup trisodium phosphate (Soilex™ or Spic and Span®) mixed in a gallon of water. Follow cleaning instructions above and manufacturer's direction. For mildew accumulation, which can occur on surfaces of all types (normally appearing as black spots), remove by using the cleaning method for moderately dirty atmospheres and basic solution of the following ingredients:

- a. 1/3 cup detergent (Tide)
- b. 2/3 cup trisodium phosphate (Soilex)
- c. 1 quart sodium hypochloride 5% solution (Clorax®, for example)
- d. 3 quarts of water

CAUTION: STRONGER CONCENTRATIONS OF CLEANERS MAY CAUSE DAMAGE TO THE FINISH. IMMEDIATELY AFTER WASHING WITH DETERGENT OR OTHER CLEANERS, RINSE ALL SURFACES THOROUGHLY WITH A GARDEN HOSE. AVOID VIGOROUS RUBBING, WHICH MAY CAUSE UNDESIRABLE GLOSS AREAS OF THE FINISH. AVOID SKIN AND EYE CONTACT. IN ALL CASES, FOLLOW MANUFACTURER'S INSTRUCTIONS FOR USE OF CLEANING COMPOUNDS AND SOLUTIONS.
